- 3. The support and wellbeing of the young
  - The charity must be registered in the UK or Wales and independently audited.
  - The charity must be independent of state, political party and religion.
  - Only charities which have been shortlisted for consideration will be contacted.
  - Applications will only be considered via email sent to enquiries@churchillfoundation.co.uk
  - One document to be sent, which is no more than 4 (A4) pages in length.
